Kapittul VI Gjald fyrir navnaprógv o.a.

§ 14. Fyri navnaprógv verður latið eitt gjald uppá kr. 1.000,- til landskassan. Gjaldið verður latið samstundis, sum umsókn um navnaprógv verður send landsstýrismanninum.

Stk. 2. Fevnir umsóknin um fleiri persónar, verður latið gjald fyrir hvønn teirra.

Stk. 3. Tó skal bert latast eitt gjald, um umsóknin fevnir um:

- 1) hjún,
- 2) systkin undir lógaldri ella
- 3) foreldur og børn teirra, sum eru undir lógaldri.

Stk. 4. Viðvíkjandi stjúk- ella fosturbörnum verður fyriskipanin í stk. 3 um systkin og børn undir lógaldri nýtt samsvarandi.

Stk. 5. Verður navnaprógv ikki givið, verður gjaldið afturrindað umsókjaranum/ umsókjarunum.

§ 15. Gjald verður ikki latið fyrir navnaprógv til barn, um umsóknin er send landsstýrismanninum innan 6 mánaðir eftir, at barnið er føtt, ella innan 6 mánaðir eftir, at barnið er ættleitt.
